They will support cloud migration enterprise-level planning and execution, versus those at a tactical level. They will assist with understanding issues around connecting to the CAP (DISA or Navy, RMF accreditation of the cloud environment, liaison with NCDOC and Fleet Cyber, process to accredit the AWS environment.) They will work with the Migration team to support the preparation of Engineering Analysis materials and events as scheduled by PMW 250, to include: development and coordination with the appropriate points of contact, review all required engineering artifacts, provide Enterprise IA expertise and guidance during document development, assist the PMW 250 Technical Director in presentation of EA events, and support all EA activities associated with system changes through the lifecycle of the Project. The Enterprise IA Specialist will provide guidance and foster a collective understanding of data flows and security issues encountered in cloud applications and services to assist with risk management and mitigation. They will perform technical contract support within the timeframe and formats assigned, meet the quality and technical requirements of the customer, and all submitted work shall be accurate and complete.
